Pension -- includes defined contribution and benefit plans for apprentices above Period 2. Pension includes an amount equal to 3% of the Basic Hourly Rate for the National Employees' Benefit Fund. (This applies to overtime rates as well.)

Health contribution is \$9.14 for 40% (1st period) and 45% (2nd period) apprentices. All other apprentices get \$10.14.

Effective 01-30-2012 -- Predetermined increase of \$1.20 (JM rate) to be allocated.

FOR PROJECTS ADVERTISED ON/AFTER 9/1/2010:

Effective 1-30-2012 -- Predetermined increase of \$1.65 (JM rate) to be allocated.
