Pension – includes amounts for defined contribution and benefit plans for apprentices above Period 2. Includes an amount equal to 3% of the basic hourly rate for the National Employees Benefit Fund which is factored at the applicable overtime multiplier for each overtime hour. Pursuant to Labor Code Sections 1773.1 and 1773.8 the amount paid for this employer payment may vary resulting in a lower taxable basic hourly wage rate, but the total hourly rates for straight time and overtime may not be less than the general prevailing rate of per diem wages.

PAY UPGRADE INFORMATION

The ABC So-Cal Electrical program is an **8,000-hour** program. Base upgrades on the following calculations: 8,000 hours divided by 10 periods, which equals upgrades **every 800 hours** for those apprentices working on projects bid under these **2022-1** determinations. **However, the ABC So-Cal Training Contribution Requirement is \$0.90 per hour. Please increase pay to include the difference of at least \$0.04 in Training at this time for periods 1-10. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.**
