## APPRENTICESHIP CLASSIFICATION: Electrician Inside Wireman

Electrical: **GUIDELINE ONLY - All counties vary on "Total Hourly Rate" for Journeyman**  
**The ABC So-Cal Electrical program is a nine (9) period / 8,000 hour program.** The starting calculation is to be based on the **2010-2** First Shift *Journeyman's total hourly package*.

Private projects: The Electrician Inside Wireman training fee for the apprentice(s) is a minimum of \$0.60 cents per hour as directed by the State and Federal Standards governing the program. However, if the determination denotes the Training Fee is higher than the contractor must pay the higher amount.

**Journeyman Basic rate – \$34.55 (L)**
