### APPRENTICESHIP CLASSIFICATION: Sheet Metal

SHEET METAL: **GUIDELINE ONLY** - All counties vary on "Total Hourly Rate" for Journeyman

The ABC So-Cal Sheet Metal program is an eight (8) period / 6,500 hour program. The starting calculation is to be based on the 2007-2 First Shift *Journeyman's total hourly package*. If the training fee is **less than** .75 cents in the determination for the apprentice the contractors must move funds from the other benefits to the training fee column to equal .75 cent to comply with the State Standards for the program. If the training fee is **more than** .75 cents in the determination for the apprentice the contractor must pay the higher amount to ABC So-Cal.
