## ORANGE COUNTY PRIVATE WORKS March 02, 2009 through March 01, 2010

### APPRENTICESHIP CLASSIFICATION: Electrician Inside Wireman

Electrical: **GUIDELINE ONLY - All counties vary on "Total Hourly Rate" for Journeyman**  
**The ABC So-Cal Electrical program is a nine (9) period / 8,000 hour program.** The starting calculation is to be based on the **2008-2** First Shift **Journeyman's total hourly package**. If the training fee is **less than** .60 cents in the determination for the apprentice the contractors must move funds from the other benefits to the training fee column to equal .60 cent to comply with the State Standards for the program. If the training fee is **more than** .60 cents in the determination for the apprentice the contractor must pay the higher amount to ABC So-Cal.

NOTE: Training fee has been adjusted and calculated in the total package to follow the ABC So-Cal State Standards. According to the Division of Apprenticeship Standards, Santa Ana Office, the difference between the training fee noted in the DLSR Apprentice Wage Rates and the required ABC So-Cal training fee can be taken out of any of the other areas of the benefit package.
