Figure represents combined total for defined contribution and defined benefit plans. There is no local pension contribution for 40% and 45% apprentices. All others get percentage of \$11.47 equal to their percentage in the program. Local pension is allocated \$6.32 to defined benefit (pension) and \$5.15 to defined contribution (annuity).

Health contribution is \$6.74 for 40% and 45% apprentices. All other apprentices get \$7.74. No \$0.40 deduction for training on apprentices; employers pays \$0.61. Includes \$0.05 for establishment and maintenance of substance abuse.

Pension: Includes an amount equal to 3% of the Basic Hourly Rate for (NEBF) National Employees Benefit Fund. (This applies to overtime rates as well.)

Other: LMCC (Labor Management Coop Committee) \$0.30.

Vacation and holiday included in base hourly rate.

Pre-determined increases (previously omitted in error) are as follows:

7-26-2010: \$1.60 (JM) allocation to be determined,  
1-31-2011: \$1.65 (JM) allocation to be determined.
