### PAY UPGRADE INFORMATION

The ABC So-Cal EST/VDV program is a **4,800-hour** program. Base upgrades on the following calculations listed above for those apprentices working on projects bid under these **2011-2** determinations. *However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$4.53 per hour as of June 1, 2011, and the ABC So-Cal Training Contribution Requirement is \$0.75 per hour. Please increase pay to include the difference of at least \$2.53 in H/W, and \$0.75 in Training for a total of \$3.28 at this time for periods 1 and 2. Please increase pay to include the difference of at least \$0.75 in Training at this time for periods 3 and 4. Please increase pay to include the difference of at \$0.45 in Training at this time for periods 5 and 6. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.*
