Footnotes:

An amount equal to 3% of the basic hourly rate is added to the pension.

Pension – No pension contribution for 45% and 50% apprentices indentured after 11/29/04, contribution for all other apprentices shall be their period percentage of the current annuity rate.

Health contribution for 1st and 2nd period apprentices indentured after 11/29/04 shall be \$2.00 per hour.

Training – No training contribution for 1st, 2nd, 3rd, 4th period apprentices indentured after 11/29/04; \$.30 training contribution for 5th and 6th period apprentices indentured after 11/29/04.

Each employer shall make the \$.05 per hour deduction for each hour worked however no deduction for apprentices indentured after 11/29/04. Exception, all hours worked in excess of 150,000 man-hours during one calendar year and all hours worked by 1st, 2nd, 3rd and 4th period apprentices indentured after 11/29/04.
