A 7/1/2011 \$.65 JM reallocation of wages (with a \$.49 decrease of BHR, and increases of \$.75 to H&W, \$.20 to Local Pension, and \$.19 to National Pension) is reflected in the apprentice wage chart above, effective 8/22/2011.

#### PAY UPGRADE INFORMATION

The ABC So-Cal HVAC program is an **8,000-hour** program.
