Predetermined increases(JM):

Eff. 2/1/12 -- increase of 1.55, with \$.05 to Training and \$1.50 to be allocated to wages and /or fringes.

Eff. 8/1/12 -- increase of \$1.50 with \$.05 to Training and \$1.45 to be allocated to wages and/or fringes.

Eff. 2/1/13 -- increase of \$1.55, with \$.05 to Training and \$1.50 to be allocated to wages and/or fringes.

Eff. 8/1/13 -- increase of \$1.75, with \$.05 to Training and \$1.70 to be allocated to wages and/or fringes.

Eff. 2/1/14 -- increase of \$1.80, with \$.05 to Training and \$1.75 to be allocated to wages and/or fringes.

PAY UPGRADE INFORMATION

The ABC So-Cal HVAC program is an **8,000-hour** program. Base upgrades on the following calculations: 8,000 hours divided by 8 periods, which equals upgrades every **1000 hours** for those apprentices working on projects bid under these **2011-2** determinations. **Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.**
