PAY UPGRADE INFORMATION

The ABC So-Cal HVAC program is an **8,000-hour** program. Base upgrades on the following calculations: 8,000 hours divided by 10 periods, which equals upgrades every **800 hours** for those apprentices working on projects bid under these **2010-2** determinations. **However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$4.26 per hour as of July 1, 2010. Please increase pay to include the difference of at least \$0.56 in H/W at this time for period 1 and 10. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.**
