Basic Hourly rate - Includes an amount withheld for administrative dues.

Dues Check Off, first year apprentices, \$0.45 & \$0.65 = \$1.10.

Dues Check Off, second - fifth year apprentices, \$0.95 & \$0.65 = \$1.60.

Pension includes: amounts for Pension, National Pension and Retiree's XMAS Fund

Other - Includes: amounts for PIPE-LMCC and for CED (Contractor Education Development Fund)

These Rates are for SHIFT 2 PAY.

#### PAY UPGRADE INFORMATION

The ABC So-Cal Plumbing program is a 7,200-hour program. Base upgrades on the following calculations: 7,200 hours divided by 5 periods, which equals upgrades every 1,440 hours for those apprentices working on projects bid under these 2011-2 determinations. However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$4.53 per hour as of June 1, 2011, and the ABC So-Cal Training Contribution Requirement is \$0.75 per hour. Please increase pay to include the difference of at least \$4.53 in H/W, and \$0.35 in Training for a total of \$4.88 at this time for period 1. Please increase pay to include the difference of at least \$0.28 in Training at this time for period 2. Please increase pay to include the difference of at least \$0.27 in Training at this time for period 3. Please increase pay to include the difference of at least \$0.22 in Training at this time for period 4. Please increase pay to include the difference of at least \$0.19 in Training at this time for period 5. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.
