PAY UPGRADE INFORMATION

The ABC So-Cal HVAC program is an **8,000-hour** program. Base upgrades on the following calculations: 8,000 hours divided by 8 periods, which equals upgrades every **1,000** hours for those apprentices working on projects bid under these **2009-1** determinations. **However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$3.76 per hour as of June 1, 2009. Please increase pay to include the difference of \$0.36 in H/W. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.**
