PAY UPGRADE INFORMATION

The ABC So-Cal Sheet Metal program is a **6,500-hour** program. Base upgrades on the following calculations: 6,500 hours divided by 10 periods, which equals upgrades every **650 hours** for those apprentices working on projects bid under these **2011-2** determinations. **However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$4.53 per hour as of June 1, 2011. Please increase pay to include the difference of at least \$0.56 in H/W at this time for periods 1 thru 5. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.**
