PAY UPGRADE INFORMATION

The ABC So-Cal Sheet Metal program is a **6,500-hour** program. Base upgrades on the following calculations: 6,500 hours divided by 10 periods, which equals upgrades every 650 hours for those apprentices working on projects bid under these **2009-1** determinations. **However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$3.76 per hour as of June 1, 2009. Please increase pay to include the difference of \$0.34 in H/W for periods 1-4.**
