PAY UPGRADE INFORMATION

The ABC So-Cal EST/VDV program is a 4,800-hour program. Base upgrades on the calculations listed above for those apprentices working on projects bid under these 2021-1 determinations. *However, the ABC So-Cal Health and Welfare (H/W) for the apprentices is \$6.45 per hour as of June 1, 2020, and the ABC So-Cal Training Contribution Requirement is \$0.90 per hour. Please increase pay to include the difference of at least \$1.62 in H/W, and \$0.60 in Training for a total of \$2.22 at this time for periods 1 and 2. Please increase pay to include the difference of at \$0.60 in Training at this time for periods 3 thru 6. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.*
