Dues Check Off: Period 1: \$1.35, Period 2-5: \$1.85. Vacation: Period 1: \$1.76, Period 2: \$2.06, Period 3: \$2.36, Period 4: \$2.65, Period 5: \$2.95

Pension: Includes amounts for Pension, National Pension and Retiree's Christmas Fund

Vacation: Included in the basic hourly rate, and factored at 1.5 for all overtime.

Other: Includes amounts for PIPE, LMCC, and CED (Contractor Education Development Fund)

** Journeyman and Apprentice Predetermined Increases:

09-01-2021: \$2.26 to be allocated to wages and/or fringes.

09-01-2022: \$2.26 to be allocated to wages and/or fringes.

09-01-2023: \$2.35 to be allocated to wages and/or fringes.

09-01-2024: \$2.50 to be allocated to wages and/or fringes.

09-01-2025: \$2.50 to be allocated to wages and/or fringes.

PAY UPGRADE INFORMATION

The ABC So-Cal Plumbing program is a 7,200-hour program. Base upgrades on the following calculations: 7,200 hours divided by 5 periods, which equals upgrades every 1,440 hours for those apprentices working on projects bid under these 2021-1 determinations. *However, the ABC So-Cal Health & Welfare Requirement is \$6.45 per hour. Please increase pay to include the difference of at least \$6.45 in Health & Welfare at this time for period 1. Please refer to ABC website under Notice of Understanding for possible rate increase on or around every June 1.*
